# MOTOR MILL BRIDGE GRAND OPENING AND CELEBRATION

The event is Saturday, May 4, from 11 a.m. to 2 p.m. Plans so far include booths from partners in the bridge project, food available for sale from the Elkader Lions Club, a program at 1 p.m., and a program by Marlys Svendsen on the Motor Mill Historic Site. Stone will prepare a slide program on the bridge construction.

There will be speakers from the Iowa Natural Heritage Foundation, Silos and Smokestacks, the Klink/Johnson family, Turkey River Recreational Corridor, RC&D, the National Park Service, the Iowa Department of Cultural Affairs, the Clayton County Conservation Board, the Clayton County Board of Supervisors, state legislators, and Congressional representatives. The board discussed the need to keep each person's remarks brief.

Buchholz received word that Linda Lucy will represent U. S. Senator Tom Harkin.

There will be a "turkey dash" after the event. Participants can donate \$5 and receive a rubber turkey to float in the river. Proceeds from the race will go to the Turkey River Recreational Corridor.

The board scheduled a clean-up day for Monday, April 29, at 9 a.m., to prepare for the event.

#### SUB-COMMITTEE REPORTS

TURKEY RIVER RECREATIONAL CORRIDOR

Collins gave the following report on the April Turkey River Recreational Corridor meeting:

The Clermont Visioning Committee is working on the trail design;

Elgin is working on a streetscape plan;

Elkader has sold several tables and planted several trees in Founders Park; There will be a "Dueling Pianos" fundraiser for Elkader playground equipment at Johnson's Restaurant on April 20.

Collins also asked to resign from her position as TRRC delegate, after serving for about three years.

**FACILITIES** 

Lenth reported that erosion caused by recent high water has exposed more of the stone dam, as well as some wooden beams, on the north bank of the river above the Mill.

Lenth suggested that it would be helpful to burn the dead vegetation on the riverbank upstream from the Mill.

Lenth has assembled a dust collector that deNeui acquired to use with power tools in the Mill.

Lenth will try to rebuild the donated millstone crane, which apparently had been modified from its original size.

#### COMMUNICATIONS

Nikolai suggested revising the Friends of Motor Mill solicitation envelopes to include the suggestion that donors include Motor in their wills or estate plans.

Nikolai asked board members to seek donations for prizes in the May 4 "Turkey Dash."

Collins reported that the Clayton County Historic Preservation Commission is working with county officials to plan extensive repairs that will be needed on the Courthouse clock tower.
