INTERN GRANT

Tracy Ott, an Iowa State University student from Elkader, has been hired to work 32 hours per week, starting min mid-May. Duties will include developing lesson plans, outdoor displays, and hands-on activities. The intern also will transcribe "memories" stories that have been compiled by volunteers.

MOTOR MILL TRAIL

Several landowners have told Engelhardt they will not allow archeological surveys on their land. Engelhardt believes he still has a good relationship with the property owners, but they have personal reasons to oppose the trail on the old railroad bed between Motor and Elkader.

After considerable discussion, the board agreed to hold a special meeting at 9 a.m. on Monday, April 28, to consider other trail options. Engelhardt will invite Eli Garms, of Clayton County Secondary Roads, to bring maps of the area.

REGIONAL TRAIL COUNT

The NE Iowa regional trails committee plans to count trail users on Saturday, May 10, and Thursday, May 17, from 6 a.m. to 8 p.m. each day. Board members should contact Engelhardt to volunteer for one or more two-hour shifts.

STORIES IN STONE CAPITAL CAMPAIGN

Collins shared a fund raising packet she has used successfully for the George Maier Rural heritage Museum. She strives to send a letter, including a brochure and donation envelope, to every visitor.

SPEAKING TO PROMOTE MOTOR MILL

Nikolai and Engelhardt spoke to the Clayton County Farm Bureau on April 3.

Harkrader suggested contacting the Driftless Area Wetlands Centre at Marquette about a program there.

Stone said that Floyd Sanford, who works in Cedar Rapids but has a home near Garber, is willing to volunteer when he's in the area, but he's not regularly available to serve as a board member.

Nikolai has talked with Barb Lichen, of Guttenberg, who is the new president of the Garnavillo Historical Museum. The Museum may be willing to work more closely with the Motor Mill Foundation.
