### **OLD BUSINESS**

1 – MASTER INTERPRETIVE PLAN – Pollock asked Foundation members to review draft and send comments and edits to herself or Harkrader. Zichal suggested a Pizza Party in November to meet and review the plan.

Pollock noted that the plan does not include interpretive videos and may suggest adding that. The board discussed the need to make a video or picture board showing renovations and progress of work at the site.

Pollock and Harkrader are seeking funding through the UMGC and SILOS to implement some of the interpretation suggestions in the Master Plan.

- 2 LUMBER SALE The "Used Lumber Tag Sale" will be Saturday, October 22, 9:00 a.m.- 4:00 p.m. at the Mill. Morine provided a description for advertising the sale. Nikolai will investigate advertising in the local Trader and Shoppers. Lenth plans to notify his Amish contacts. Harkrader will put the sale on Facebook and the website.
- 3 TURBINE RESTORATION Schoen received an email from Maryland about the turbine restoration project and an invoice for the 2<sup>nd</sup> half of the payment for \$4078.00. They are near completion and will soon let us know when the turbines are ready to return.

- 4 WORK ON 5<sup>TH</sup> FLOOR Slagel said the flooring has been repaired behind the smutter. Tuesday volunteers have begun work on the hole on the upstream side of the 5<sup>th</sup> floor and will finish closing it in next week.
- 5 FIRE SAFETY REQUIREMENTS FOR HISTORIC BUILDINGS Nikolai asked if a second set of stairs is required for fire safety in historic buildings. Pollock said she will check with the historic preservation experts.
- 6 FUNDRAISING FOR THE INN Pollock plans to send 2 fundraising letters soon to former supporters of the Inn and to a more generalized list of doners. Pollock suggested that the foundation wait until the 2023 season to plan any fundraising events.
- 7 VISITS TO OTHER MILLS Zichal said Beck volunteered to drive 5 people on Saturday, September 24<sup>th</sup>. Plans are to leave at 8 a.m. and be back by 4 p.m. Nikolai will confirm with Schech's Mill for a tour at about 9:30 or 10:00 followed by Pickwick Mill. Zichal said there is a nice spot for lunch near Pickwick Mill.

#### **NEW BUSINESS**

1 – OSBORNE HERITAGE DAYS – Chuck suggested the Board open the Mill for Sunday too. Slagel and Zichal volunteered to cover both days at the Mill and Chris can help where needed. Chuck will move the stuff to Osborne at 4pm Friday for those who want to help set up the booth. Morine suggested a new banner at the booth that says Motor Mill and can withstand wind.
