## **OLD BUSINESS**

1 – BRIDGE LIGHTS – Pollock said the Conservation Board staff and other volunteers will have cookies and hot chocolate to serve at the bridge lighting on Saturday, November 19. The Mill will be open from 4:30 to 6 p.m., with the lights turned on at 5 p.m. There also will be a soup supper to benefit the Littleport Fire Department at the Littleport Church.

2 – TURBINE RESTORATION – Schoen said it would cost \$363.66 per month to store the turbines in Maryland until spring. Thus, he and Nikolai plan to go get them the last week in November.

## **NEW BUSINESS**

1 – DESTINATION IOWA GRANT – Pollock requested that the Foundation sign on as a co-applicant for the \$150,000 grant the Conservation Board is applying for to help pay for Inn restoration. Slagel moved that the Foundation join the application. Morine seconded. Carried.

Pollock also reported that she has been in contact with Shawver Well and Fehr-Graham Engineering about options for a well to serve the Inn. The choices seem to be a new well, or horizontal drilling through the bluff from the campground well. She will investigate further.

Schoen noted that the State Historic Preservation Office may have concerns about whether a well house might not be appropriate close to the historic buildings.

2 – MATERIALS TO STORE AT MOTOR IN WINTER – Morine said he plans to take all the merchandise and clothing to Osborne, but probably will leave brochures and other display items.
